

Calhoun Sandcrab Stadium Rules and Regulations

UIL Constitution and Contest Rules, Section 21: RESPONSIBILITIES OF THE SUPERINTENDENT

The Superintendent of a member school district:

(a) shall exercise direction and management of all League contests and scrimmages in which schools in the district compete, including appointing a game administrator for all home UIL varsity athletic team contests. The designated game administrator for all CCISD home UIL varsity athletic team contests shall be the Calhoun High School Principal. Depending on the number of home UIL varsity athletic team contests, the Calhoun High School Principal may designate a game administrator for each contest.

We have a synthetic turf field at Sandcrab Stadium. We also have a new track surface as of 2015. Listed below are the rules and regulations that we expect everyone to follow:

1. No liquids other than water can be present on the field or track. (No sodas, Gatorades, etc.)
2. No food of any kind is allowed on the field or track.
3. No chewing gum, candy, sunflower seeds, or tobacco on the field or track.
4. Motorized vehicles must stay off the track. Crossover mats will be provided.
5. Only motorized vehicles approved by our Maintenance Director may drive on the field.
6. Do not place tables, chairs, band stands, or benches on the field or track without the proper mats underneath or field feet. (Field feet is a covering that goes on the bottom of chairs, tables or benches to help protect the surface it sits on.)
7. No metal football or soccer cleats will be allowed on field or track.
8. Rubber based cleats are fine but we ask that players use the cross-over mats when going across the track to the field or leaving the field.
9. Half time warm-ups for the visitors must take place on the north end of the field on the turf area behind the end zone.
10. Half time warm-ups for the Calhoun team will take place on either of the high jump aprons on the south end of the stadium.
11. Blow up helmets or run through signs for the visiting teams will be set up on the northwest end zone.
12. The blow up helmet and run through tunnel for Calhoun will be set up on the southeast end zone.
13. No pyrotechnic devices or anything that requires heat to activate will be allowed on the field or track.
14. No confetti of any type will be allowed on field or track.
15. No painted signs will be allowed on the field or track. Permanent banners only.
16. No outside food or drinks are allowed in Sandcrab Stadium. All glass bottles are prohibited.
17. Do not empty coolers on the field or track. Please empty coolers in the drain areas outside of the field.
18. Spectators are not allowed on the field before or after the game. Please remain off of the turf. Spectators will be allowed on the track after the game is over.
19. No unauthorized personnel will be on the sidelines without a pass. The game administrator will approve all sideline passes.
20. No warming up for track meets on the turf field. All warm-ups will be done on the grass practice field behind the Travis field house.
21. The policy for the community using the track will be posted at the gate. Times and procedures will be included with what will be allowed and not allowed.
22. All community athletic organizations must go through the Athletic Office and complete a facility usage agreement before using Sandcrab Stadium. The Athletic Director will approve the usage after consulting with the Maintenance Director and Superintendent.
23. Press desiring sideline access must be authorized by the game administrator and must possess valid press credentials.
24. Individuals are not allowed to film UIL competitions at Calhoun Sandcrab Stadium. Access to the film deck will only be for sponsors/coaches of performing groups, or their filming designee. (See attached UIL Constitution and Contest Rules)

UIL Constitution and Contest Rules states:
Section 1208

(m) VIDEOTAPING AND FILMING.

(1) *Non-Conference and District Contests.*

(A) *Videotaping/Filming by Schools.*

(i) It is a violation to videotape or film a non-conference or district athletic contest in which your school or team is not competing unless prior consent of the two schools involved has been obtained.

(ii) A school does not have to obtain permission to film or tape a non-conference or district contest in which it is competing. However, the film or videotape may not be utilized until after the contest has been completed.

(iii) Films and videotapes become the property of the school doing the filming unless by district rule or by consent of the schools involved in the contest.

(B) *Videotaping/Filming by Individuals.* Any individual taping or filming shall have permission from the schools involved in the contest and may not obstruct the view of other spectators of the contest.

(C) *Commercial Uses.* Use of the films or tapes for commercial purposes shall be approved by all schools involved in the contest.
